Please also refer to this website for detailed information concerning the NFP programme and the application procedure. **Since Nuffic will strictly adhere to the above mentioned deadline, we strongly recommend that you submit your application well in advance.**

In case you have limited access to internet you can apply for NFP fellowship using a hard copy application. Please let us know and we will mail you the application form.

The number of NFP/TP fellowships available is limited and admission to the course is on a competitive basis. Once you have applied for a NFP fellowship, you are registered in the SOL-system and you can check the status of your application on-line. The final selection of candidates will take place 16 weeks after the NFP fellowship application deadline. Shortly thereafter you will be informed by Nuffic on the outcome of your application.
